

## **Terms & Conditions of Participation**

By completing a registration form as a participant, a parent or guardian, you are registering yourself or your child/ren to play with Epping Storm Basketball Club (Club) and acknowledge that you have read the contents of the registration form and consent to being bound by these terms and conditions and to their participation in the sport of basketball:

- I agree or hereby give permission for my child/ren to participate in training and playing for Epping Storm Basketball Club.
- I/we will pay all fees in accordance with the fee schedule by the due date. I agree that registration fees are NON-REFUNDABLE and agree to be bound by the Club's Refund Policy.
- 3. If registered as a player participant, I agree to be bound and to abide by (observe) the Rules and Policies of Epping Storm Basketball Club, and Whittlesea City Basketball Association (WCBA), and the Basketball Victoria Codes of Conduct in relation to Players, Coaches, Parents and Spectators. This includes any conditions of entry into all basketball venues.
- 4. If registering my child/ren, I agree that my child/ren and myself as a parent or guardian are bound and will abide by (observe) the Rules, Policies and Codes of Conduct referred to herein.
- 5. If registering a child/ren under 18 years old, I will ensure an adult/guardian is present at all games and training sessions to supervise and be responsible for my child/ren.
- 6. I/we acknowledge that basketball is a body contact sport in which physical injury canoccur from time to time and will not under any circumstances hold the Club liable for any accident or injury that may occur.
- 7. If registered as a player participant, I acknowledge that I am responsible for first aid/medical decisions in the event of an injury/medical event at a game or training session and that the cost of any ambulance or medical treatment is my sole responsibility. If registering my child/ren, I acknowledge that I am responsible for first aid/medical decisions for my child/ren in the event of an injury/medical event at a game or training session and that the cost of any ambulance or medical treatment is my sole responsibility as parent/guardian.
- 8. I/we authorise the Coach, Team Manager or authorised representative of the Club, to obtain emergency medical treatment for the player when it is not reasonably practical for the player or parent/guardian (as the case may be) to do so and acknowledge and agree that I, as the player, or as the parent or guardian (as the case may be) am responsible for all associated costsincluding specialist services such as an Ambulance.

- 9. I agree to contribute to my team, or my child/ren's team including scoring or other bench and associated duties as requested by the Coach or Team Manager.
- 10. I agree to receive all Club communication including game times, or Club events via email, text, call.
- 11. I agree that my name or my child/ren's name including first name and surname (not address) maybe published on team lists on the Club's website as well as PlayHQ unless otherwise requested in writing.
- 12. I understand that the Club may take photographs of me as a player participant, or my child/during training, games, tournaments or special occasions, and retains the right to use them for publicity purposes on the understanding that no child will be identified by name in any published photograph without the express permission of the player participant (if over 18 years of age) or the parent/guardian.
- 13. If registering as a player participant, I agree not to disparage, denigrate, slander, libel or otherwise defame the Club, or anyone associated with the Club including Coaches and other players via any social media platform. If registering my child/ren, I agree that neither myself nor my child/ren will disparage, denigrate, slander, libel or otherwise defame the Club, or anyone associated with the Club including Coaches and other players via any social media platform.
- 14. I acknowledge that I may access copies of the relevant Rules, Regulations and Policies referred to in these Terms and Conditions via the Club website or upon request to any of the relevant bodies including the Club.
- 15. I acknowledge that any failure by the player participant, parent or guardian to adhere to these Terms and Conditions, or the Rules, Regulations and Policies of the Club, the WCBA and Basketball Victoria, may result in you or your child being sanctioned or deregistered.
